

Southwest Airlines Name Change Policy: Fix Errors and Update Passenger Information

Understanding Southwest's Name Correction Rules

Discovering an error in your name after booking can cause anxiety about your upcoming trip. ☎ +1/844/565/1867 Southwest Airlines allows minor name corrections but has strict policies regarding name changes. The key difference is that corrections fix typos or spelling errors, while name changes transfer tickets to different people, which Southwest does not permit. Minor Name Corrections vs Complete Name Changes

Southwest distinguishes between minor corrections and complete name changes. ☎ +1/844/565/1867 Minor corrections include fixing spelling errors, adding or removing middle names, or correcting transposed first and last names. These are generally allowed and may be done with minimal fees. Complete name changes that transfer the ticket to another person are strictly prohibited. How to Request a Name Correction

More significant corrections or changes made close to departure may incur fees. Basic Economy fares typically have less flexibility and may have higher fees or restrictions. The exact fee varies based on your specific situation and the type of correction needed.

When Name Corrections Must Be Made

Some corrections cannot be made after online check-in has been completed. Legal Name Changes After Marriage or Divorce

Southwest can update your ticket to reflect your new legal name when proper documentation is provided. Make sure your government-issued ID matches your ticket name, or bring documentation proving the name change when traveling.

International Travel Name Requirements

For international flights, name accuracy is even more critical. 📞 +1 / 844 / 565 / 1867 Your ticket name must exactly match your passport as immigration officials strictly enforce this requirement. Even minor discrepancies can result in denied boarding. Check your passport spelling before booking international flights. Middle names should match exactly, and suffixes like Jr., Sr., or III should be included if they appear on your passport.
